The successful candidates will be passionate and enthusiastic whilst working with children in all aspects of their care, learning and development. The candidates will have sound knowledge of the Early Years Foundation Stage and have the ability to plan for, deliver, record and assess the elements within the EYFS.

Key Responsibilities:

- Provide high quality care and activities for the children in a secure, safe and stimulating environment
- To act as a key person to a small group of children, liaising closely and building an effective relationship with parents/carers and ensuring each child's needs are recognised and met
- To regularly observe and record children's achievements in line with the EYFS
- To liaise with parents and encourage their involvement in the aims and ethos of the nursery and in all aspects of the children's care
- To promote at all times good relations between staff members, parents and children, and promote the ethos of the Nursery
- Carry out risk assessments as required to ensure safety of children
- Ensure you are always familiar with the key policies and procedures, especially safeguarding and health and safety
- Continuation of personal and professional development to ensure knowledge and skills are up to date, full, and relevant to the role
- Working as part of a larger team to ensure all essential day to day tasks are completed in line with the Nursery demands i.e. Hygiene standards and room preparation
- To assist in the preparation of snacks and provide mealtime supervision
- Be familiar with the Nursery designated co-ordinators such as Safeguarding and SENCO
- Attend training and development courses as required
- Any other duties appropriate to the role as directed by the Management

- **Personable:** Building positive relationships with parents is something that you'll need to be good at. By communicating and working together, you can make sure a child is happy, healthy and gets all of the support they need, both from you and at home
